- g) Joining devices should always be tightened properly and regularly verified. Tighten if necessary.



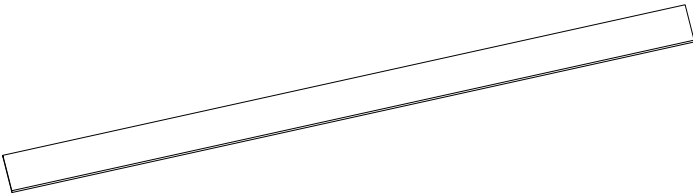
